### About the Role and the Person in this Role

You will be our firm's first legal Fellow and this appointment will last for 12 months (September 2022 - September 2023). In this role, you will learn all about nonprofit organizations, exempt organizations, and how they work. You will gain first-hand experience in governance, grant-making, tax, and other nonprofit corporate issues.

You will gain wide exposure to representing nonprofit organizations on interesting and complex legal projects, given the varied nature of TLCF's clients. You will support the review, negotiation, and drafting of a wide variety of agreements and will lead an extensive research or writing project during your fellowship while providing practical advice and counsel to clients.

You will also assist the Managing Attorney, Associate Attorneys, and the other member of the TCLF team, with nonprofit and tax-exempt organization matters, and with research and writing on all aspects of nonprofit governance and tax-exempt organizations law. You will have client contact and provide support to the attorneys within TCLF serving as General Counsel to clients. Additionally, you will work with our nonprofit fiscal sponsor, Build Up Inc., on projects that provide integral support to organizations and projects in need of infrastructure.

In this role, the successful candidate will be passionate about working with non-profits and believe it is critically important to be highly responsive to our clients' needs. You are willing to assist in any way that is needed and offer solutions to any challenges that arise. You are excited to work in an environment where each day can vary and enjoy working in a fast-paced start-up environment.

## What the Role Requires

- Strong interpersonal skills
- Deep commitment to the nonprofit sector
- A genuine interest in what is happening socially, politically, and philanthropically in the United States, the Caribbean, and Sub-Saharan Africa
